# Flowcart Inc. Privacy Policy

#### **Information We Collect**

## **Use of Information**

- 2.1 Order Processing and Fulfillment: We use the information we collect to process and fulfill your orders, facilitate communication between brands and resellers, and provide you with the requested services. This includes sharing relevant information with the respective brands and resellers involved in the order process.
